Sub: Asset Focal Persons and AIS update

The Supreme Court of Bhutan in collaboration with the Department of National Properties (DNP) has successfully completed the sensitization workshop on Asset Inventory System (AIS) and Property Management Manual (PMM) on 20th February 2020. The two days' workshop was aimed at introducing AIS and PMM to the Asset Focal Persons of the Judiciary of Bhutan particularly on five main non-expendable properties such as Land, Building, Vehicle, Equipment and Furniture.

All the participants have been trained and nominated as Asset Focal Person for respective offices as per the list attached. At the same time, the DNP Focal Persons have provided user credentials to all participants in using the AIS with immediate effect.

Therefore, you are asked to render necessary support to your Asset Focal Person in updating the current and future assets of the office. To enable the Asset Focal Persons to understand the scope of their work, a TOR has been enclosed here for kind reference. You may kindly note that the Supreme Court is not liable for any discrepancies due to non-adherence to the AIS by your office. In case of transfer/superannuation of the Asset Focal Person, kindly ensure the continuity with nomination of a new Asset Focal Person through provision of training/orientation by the outgoing Focal Person.
