Evaluation Report on Vehicle maintenance services

1. Introduction

This report evaluates bids submitted for the vehicle maintenance services. As all the bidders have met the general criteria specified in the bidding document, the evaluation committee conducted a further assessment based on the item rates submitted, readiness (**based on past experience**), availability of equipment and stock of spare parts on hand. The evaluation did not only consider the lowest quoted amount but also focused on identifying the bidder with the highest capability to ensure reliable and effective service as well.

1. Evaluation Summary

2. Detail Findings

The evaluation committee upon close verification of the quotes submitted by the bidders found out that the lowest bidder for the lot has quoted alarmingly low. Following items but not limited to were identified for which the rates are significantly below the market averages which is raising red flag about the quality that they might supply if it needs to be changed.

1. Radiator for the Prado 2010 – Nu:5500;
2. Turbo Core Assembly for Prado 2010 –Nu: 16500
3. Alternator Prado 2010 –Nu 450
4. Intercoolers –Nu:875
5. Windshield Set Front for Vigo Hilux-Nu:750
6. Turbo Core Assembly for Vigo Hilux-Nu:15000

There are also many items which are not listed but with lower rates than the average market rates. In general the bidder has quoted very low price for the parts that may or may not be used over the year to bring down the overall lot amount. This could significantly pose potential risk of receiving counterfeit substandard parts if it need to be changed. Considering the above the evaluation committee has called all the bidders to Supreme Court for confirmation meeting of the rates that they have submitted and was asked to ready the parts for verification. Upon Verification the committee has found out that the lowest bidder could not furnish all the listed parts and also it was noted that they don't have proper workshop space and mechanics.

2.1 Namsey Workshop

Stock-in-hand: Average inventory of common parts and lacks quick response to our demand for sample spare parts as notified.

Equipment: Functional for standard repairs but lacks advance tools for complex tasks.

Readiness: Learnt from the past work experience, the firm has demonstrated an average setup which needed repeated reminder and struggled during high demand situation.

2.2 Chhimi Workshop

Stock-in-hand: The firm has demonstrated quick response to our demand for sample spare parts as notified.

Equipment: The firm has adequate manpower and advance tools which can cater to our urgent requirements.

Readiness: Can meet our urgent demand for maintenance considering their well-equipped tools, adequate manpower and well stock in hand.

2.3 Lungten Workshop

Stock-in-hand: The firm has demonstrated quick response to our demand for sample spare parts. However, the firm was not able to produce one item as notified.

Equipment: The firm has adequate manpower and advance tools which can cater to our urgent requirements.

Readiness: Can meet our urgent demand for maintenance considering their well-equipped tools, adequate manpower and well stock in hand.

3.Recommendation

The evaluation Committee after thorough examination has found out that in general the individual items rates showed wide variations within the bidders but in comparison the lowest bidders of the lot has quoted substantially low for non-running parts. This enabled him to be at the lowest but will significantly compromise timely delivery and will enhance the chances of supplying substandard parts. Therefore, the evaluation committee decided to recommend second lowest bidder (Chime Workshop) to be awarded the work considering their readiness, stock-in-hand and quality equipment which aligns best with our requirement for efficient vehicle maintenance.

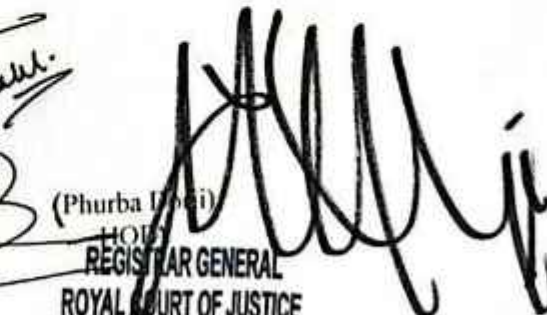

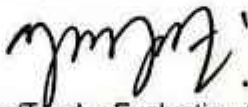

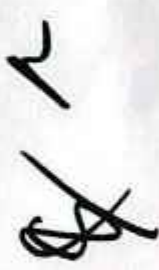
