- (5) Valid Audit Clearance Certificate

## For Judicial Personnel:

- (1) For Meritorious Promotions Executive Performance Appraisal Forms for the last three years (2020 July-2021 June; 2021 July -2022 June; 2022 July-2023 June) (Refer to the Judiciary website)
- (2) For Broadband Promotions IWP for the last three years (2020 July 2021 June; 2021 July-2022 June; 2022 July 2023 June)
- (3) Promotion Summary Form (13/2)
- (4) Valid Audit Clearance Certificate
- (5) Valid Security Clearance Certificate
- (6) No Case Pending Certificate
- (7) Last Promotion Order (if it is not the first promotion)

\*Please note that judicial personnel can apply for S1 to SS1 promotions after 4 years\*

Therefore, all are requested to strictly adhere to this notification. Kindly note that the proposals submitted after the deadline or incomplete proposals shall not be entertained. Please ensure all documents are completed and attached. The Human Resource Division will not be responsible should any promotions be denied due to incomplete documents.
